Note :- (5) If the documents produced by any candidate are found defective the commission reserves the right for rejection of their candidature at any stage of selection as per rule.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed, but answer scripts can be rechecked after the publication of ranked list. Detailed instructions will be published in the ranked list notification to be published for the post.

Note :- (7) Those candidates included in the short list based on community claim are required to produce community certificate/non-creamy layer certificate issued by the revenue authority at the time of OTR verification.

Note :- (8) Copy of answer scripts of the OMR test held on **27-02-2020** will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the ranked list. No candidates are invalidated in this test (Refer notification No.ER IX(2)2447/2020/EW dated 19-04-2022).
